From e-Cigarettes to Hookahs: Current Trends in Tobacco & Smoking

Attendees will learn how to use new materials and technologies to preserve tooth structure and provide affordable, life enhancing treatments for their patients.

During this fast-paced course, attendees will learn about biomechanical function and preservation of tooth structure during bulk filling, bonding and composite restoration procedures. Minimally invasive concepts and methods are explored using a combination of lecture and hands-on exercises in three modules.

Module 1: Dentin substitution using a biomimetic bulk-fill composite material (tooth#16, MOD-LI, class II)

Module 2: Placement of a pre-fabricated direct composite veneer (Componeer)

Module 3: Freehand restoration using a next-generation universal submicron composite (anterior class IV, tooth #21), matching veneer placed in Module 2

As a researcher, Penny focuses on periodontal disease, the use of photodynamic/photodysinfection therapy, implants and oral self-promotions. She has published and co-authored in multiple journals and has composed and presented webinars internationally.

As a clinician, she has practiced with a periodontal/prosthetic specialty team for the last 18 years. Penny is British Columbia's Dental Hygienist Representative on the PDC Organizing Committee, speaks at several study clubs and conferences, and has created a consulting company, UpScale Consulting, to assist Dental Hygienists and their teams to achieve the highest standard of care.

OVERVIEW

Technology has allowed dental implants to be more accessible to patients, which has the ability to improve their oral health. As primary health care providers, Hygienists play a pivotal role in maintaining implants. Having fundamental knowledge of implant components, mechanism and debridement materials are central for achieving comprehensive care.

This lecture is intended for Hygienists and will focus on the assessment; diagnosis, planning, implementation and evaluation of implant components, instrumentation and overall impact on oral health.

LEARNING OBJECTIVES:

Assessment; Describe Peri-implant disease. What clinical parameters are relevant for assessing implants? Learn the criteria for producing a diagnostic radiograph. Discuss the evidence to probe or not to probe the peri-implants? Identify crucial components of the implant composition and mechanism. Diagnosis: Learn how to identify healthy, failing, ailing and failed implants. Planning: Learn to treatment plan for the healthy and diseased peri-implant. Implementation: Describe the various materials used to debride healthy and diseased peri-implants. Identify the concepts needed to effectively and safely debride around implants. Evaluation: Describe the complications, referral and recall intervals for the healthy and diseased periimplants.

Psychiatric Illness and Dentistry: Challenges for Oral Care

Dr David Clark

Dr Clark obtained his MSc in Oral Pathology at the University of Western Ontario in 1986 and is a Fellow of the Royal College of Dentists of Canada. His hospital based practice has been devoted primarily to the general dental care of individuals undergoing primary care for various forms of psychiatric illness. He instructs at the University of Toronto, Durham College (Dental Hygiene Program) and at George Brown University.



OVERVIEW

Psychiatric illnesses and their medical management carry significant risks for oral disease. Although common, diseases such as schizophrenia, major depression, bipolar disorder and eating disorders often remain unrecognized or misunderstood. Dental professionals should be aware of factors such as the reduced rates of compliance with dental treatment, the effects of psychotropic medications on oral health, including xerostoia, caries and periodontal disease. It is important for the dental health practitioner to demonstrate patience, flexibility, empathy and a non-stigmatizing attitude in caring for these individuals. Enhancing self-esteem and feelings of self-worth for those coping with a psychiatric illness can be a very fulfilling experience that will only serve to continue to break down the stigma surrounding this group of diseases.
